India Secures ₹328 Billion Deal with US for 31 Predator Drones SHARE

15-Oct-24

India has signed a \$4 billion deal with the US to acquire 31 Predator drones from General Atomics, aiming to enhance its military capabilities along the contentious China border. This procurement, finalized just before the US presidential elections, underscores the strengthening defense ties between India and the USA. With advanced surveillance and combat capabilities, these drones will significantly bolster India's operational edge in its strategic rivalry with China. The deal reflects India's proactive approach to modernizing its military in response to evolving geopolitical threats, particularly from China. The acquisition of the MQ-9B Predator drones, known for their endurance and strike capabilities, enhances India's surveillance architecture and deterrence posture. As India continues to bolster its defense partnerships, this procurement signals not only a commitment to national security but also a strategic alignment with US defense objectives in the Indo-Pacific region.

Indian Navy's VLF Station Construction Proceeds Despite Protests SHARE

Defence Analysts Advocate for Tata WhAP Over Canadian Stryker Amid Trudeau's Anti-India Remarks
