Defense Business and Industry

IAF to receive 6 Tejas jets by March 2026; delays from engine supply. Share

24-Jun-25

The Indian Air Force (IAF) is set to receive at least six Tejas Light Combat Aircraft by March 2026, despite delays attributed to US defense firm GE Aerospace's late delivery of F404 engines. HAL's CMD D K Sunil assured that the technical issues have been resolved, and plans are in place to produce 16 jets next year if engine supplies are steady. The Tejas Mk-1A, designed for high-threat environments, is crucial for IAF's modernization, especially as it seeks to replace aging MiG-21s. Additionally, HAL secured a contract for 156 light combat helicopters, enhancing India's military capabilities.

Indian Army Orders 450 Nagastra-1 Drones to Boost Precision Targeting Share

The Indian Army has placed a significant order for 450 units of the Nagastra-1R loitering munitions from Nagpur-based Solar Defence and Aerospace Ltd, valued at ₹158 crore. This follows a previous order of 480 Nagastra-1 drones and aims to enhance precision targeting capabilities within the army. The Nagastra-1R features advanced technologies such as a 360-degree gimbal camera, an optional thermal camera for night operations, a proprietary encryption system for secure communications, and a remarkable circular error probable (CEP) of just 2 meters. With over 75% indigenous components, this procurement aligns with India's Make in India initiative, reducing dependency on

foreign suppliers while boosting tactical flexibility against insurgent threats along the borders. The deployment of loitering munitions, including the Nagastra-1, has proven effective in recent operations, notably Operation Sindoor, which sought to counter terrorism through targeted strikes in Pakistan and Pakistan-occupied Kashmir. Additionally, the defense ministry's recent push for emergency procurement reflects India's commitment to rapid modernization and self-reliance in defense, ensuring that indigenous technologies play a crucial role in safeguarding national security. This move consolidates India's position as an emerging defense manufacturing hub and showcases its strategic focus on maintaining operational readiness against threats.

DRDO Proposes 28 Indigenous Weapons for Urgent Military Needs Share

The DRDO has presented 28 indigenous weapon systems for emergency procurement by the Indian Army, Navy, and Air Force, a move aligned with the Atmanirbhar Bharat initiative. This effort, driven by the recent operational success during Operation Sindoor, allows for rapid acquisition of critical weaponry, including advanced missiles and electronic warfare systems, with procurement limits set at 300 crore per item. The initiative aims to replace lengthy procurement processes and enhance India's self-reliance in defense, focusing on domestic manufacturing. By strengthening operational readiness through indigenous capabilities, India seeks to reduce reliance on foreign imports while addressing immediate security threats effectively.

Ideaforge Shares Fall 4% After Recent Surge Amid Investor Caution Share

The share price of Ideaforge Technology Ltd, a key player in the Indian defense sector, dropped over 4% despite a positive market rally, reflecting a potential exhaustion in defense stocks after a significant 45.43% surge since April 2025. The decline occurred after the stock previously hit a 10% upper circuit, amid rising expectations for increased defense budget allocations due to heightened geopolitical tensions. Analysts that while the defense sector suggest outperformed overall market indices, the recent dip indicates a cooling off period, suggesting cautious sentiment among investors as they reassess the sustainability of growth in the sector.

US to retire B-2 bombers by 2030, introducing the advanced B-21 Raider. Share

The U.S. Air Force is set to retire its B-2 bombers by 2030, transitioning to the advanced B-21 Raider, which enhances long-range strike capabilities and is designed for contested environments. With a procurement plan for at least 100 units, the B-21 aims to modernize U.S. air power alongside legacy bombers like the B-1B and B-52, which continue to play vital roles in global operations. This transition underscores the U.S. commitment to maintaining a formidable and survivable strategic deterrent. For India, the emergence of such advanced U.S. capabilities highlights the need for continued modernization and investment in its own air force to ensure robust defense readiness.

India and US to finalize F-414 jet engine deal by March: HAL S SHARE

India's Hindustan Aeronautics Ltd (HAL) is set to finalize a deal with GE Aerospace by March for the joint production of F-414 jet engines, crucial for the Tejas Light Combat Aircraft Mark 2 and the Advanced Medium Combat Aircraft (AMCA). The agreement, emphasizing an 80% technology transfer, marks a significant shift in U.S. policy on military technology sharing. Additionally, HAL secured a contract for 156 Prachand helicopters, enhancing India's self-reliance in defense. This progression strengthens India's air power capabilities and supports the government's initiative for indigenous defense manufacturing, bolstering national security and reducing dependency on foreign technology.

Andhra Pradesh targets Rs 1 lakh crore in aerospace and defense

The Andhra Pradesh government aims to attract investments of Rs 50,000 crore to Rs 1 lakh crore in the aerospace and defense sectors over the next five years, positioning the state as India's premier hub for these industries. Specialized manufacturing corridors for systems, missile production, and technologies are planned, alongside a proposed DRDO Centre of Excellence in Tirupati. With 23 companies investing Rs 22,000 crore and creating 17,000 jobs, the Chief Minister emphasized the importance of innovation, technology, and support for MSMEs, aiming to enhance national security and contribute to India's growing defense market valued at Rs 1.27 lakh crore.

Gridbots Completes KATANA Trials in Galwan Valley Successfully Share

Gridbots Technologies has successfully completed trials for its KATANA autonomous weapon station in the challenging terrain of Galwan Valley, demonstrating its advanced AI capabilities and precision in extreme conditions. Operating at high altitudes and low temperatures, KATANA showcased exceptional accuracy of 30 cm at a 400-meter range, enhancing situational awareness and threat neutralization, particularly drones. This achievement against underscores India's commitment to self-reliance in defense technology, aligning with the nation's strategic goals. The successful trials not only position KATANA as a sophisticated defense solution but also highlight the importance of indigenous innovation in modern warfare scenarios, ultimately bolstering India's defense capabilities.

Construction Begins on India's Largest Unmanned Submarine Jalkapi SHARE

The construction of India's largest autonomous underwater vehicle, the Jalkapi Extra-Large Unmanned Underwater Vehicle (XLUUV), has begun at Krishna Defence and Allied Industries Ltd in Gujarat, marking a significant step toward self-reliance in defense technology. This collaboration, supported by the Indian Navy, emphasizes India's commitment to enhancing its maritime capabilities and reducing dependence on foreign technology. The Jalkapi, equipped for diverse missions including ISR and anti-submarine warfare, signifies India's emergence as a leader in underwater

defense systems, reflecting the nation's strategic autonomy and reinforcing its presence in the Indo-Pacific region. This initiative aligns with the Aatmanirbhar Bharat initiative, fostering indigenous innovation and industrial growth.

ADA Enhances AMCA's Weapons Bay for Stealthy Air-to-Air Combat Stealthy Air-to-Air Combat

The Aeronautical Development Agency (ADA) is enhancing the internal weapons bay (IWB) of India's Advanced Medium Combat Aircraft (AMCA) to improve its air-to-air combat capabilities in stealth mode. The AMCA MkII variant is projected to carry at least six Astra MkII missiles internally, significantly increasing its lethality while maintaining a low radar cross-section. This optimization reduces reliance on external hardpoints, preserving stealth characteristics and enabling the aircraft to engage multiple targets simultaneously. Additionally, ADA is exploring the integration of the larger Astra MkIII missile, showcasing the AMCA's adaptability to evolving mission needs and solidifying its role as a formidable asset in air superiority missions.

Astra MkI Trials on Rafale to Start This Year, Live Firing in 2026 SHARE

The Astra MkI Beyond Visual Range Air-to-Air Missile (BVRAAM) is set for captive trials on the Rafale fighter jet later this year, with live firing expected in 2026. This integration, led by Dassault Aviation and India's DRDO, aims to enhance the Indian Air Force's (IAF) capabilities, as the Astra MkI outmatches the current MICA missile in range and engagement flexibility. Furthermore, the Astra MkII, with its superior performance, is anticipated to further bolster aerial superiority along contested borders. This development reflects India's commitment to reducing dependency on imported weapons while promoting its indigenous defense industry under the Make in India initiative.

Indian Army Inducts MTO UB1 Repair Vehicles for Enhanced Logistics Share

The Indian Army has inducted a new batch of MTO UB1 repair vehicles based on the Ural-4320 chassis, enhancing its battlefield logistics and maintenance capabilities. These vehicles, customized for Indian operational needs with a right-hand drive and armored KUNG shelter, ensure effective support for mechanized and artillery units in challenging environments,

including high-altitude regions. This induction aligns with India's commitment to self-reliance in defense manufacturing, promoting local production under the Make in India initiative. The MTO UB1's versatility as both a transport and repair platform enhances operational readiness, reflecting a strategic move to bolster logistics along sensitive borders.

Indian Army and IAF to Acquire 10kW Indigenous Energy Weapon S SHARE

The Indian Army and Air Force are set to procure an indigenous 10kW Direct Energy Weapon (DEW) system to enhance air defence capabilities against aerial threats, including drones. Developed by DRDO and manufactured by Larsen & Toubro, this system can destroy targets at a range of two kilometers, addressing vulnerabilities highlighted during Operation Sindoor against Pakistan-based threats. The decision reflects India's commitment to indigenous defense technologies under the Aatmanirbhar Bharat initiative. Successful trials and the potential involvement of additional production partners signify timely deployment across strategic locations, marking a significant advancement in countering asymmetric warfare tactics that adversaries may employ.

HAL Introduces HLFT-42 Trainer with Advanced Missile Capabilities Share

Hindustan Aeronautics Limited (HAL) has unveiled concept images of the HLFT-42, a next-generation trainer aircraft equipped with ten Beyond Visual Range Air-to-Air Missiles and two Close Combat Missiles, highlighting its dual-role as both a trainer and light fighter. Designed to replace the ageing BAE Hawk Mk132 trainers, it aims to bridge the gap between basic and advanced aircraft, enhancing pilot capabilities with modern avionics and an Active Electronically Scanned Array radar. The HLFT-42 not only strengthens India's self-reliance in defense technology but also positions India competitively in the global military trainer market, significant export potential driven modernization needs.

Geopolitics and Security Alliances

Iran denies missile attack on Israel amid ceasefire claims. S SHARE

Iran's military has denied allegations of launching missiles at Israel following the initiation of a ceasefire, as reported by state television. This statement comes amidst rising tensions in the region, with accusations of Iran inciting hatred against specific communities. The denial emphasizes Iran's position in the geopolitical landscape, suggesting a desire to avoid escalation while maintaining its influence. In the context of Indian defense strategies, the situation underscores the importance of monitoring regional threats, as any instability involving Iran could have wider implications for India's security and diplomatic relations, particularly with Israel and neighboring countries.

Trump Calls for Ceasefire After Iran's Missile Strike on U.S. Base Share

Following Iran's missile attack on the U.S. Al Udeid Air Base in Qatar on June 23, which struck one missile after Iran reportedly gave advance warning and most were intercepted, President Trump swiftly engaged Qatar to mediate a ceasefire between Iran and Israel. He declared a "complete and total ceasefire" effective late June 23, urging both nations to halt hostilities. However, within hours. Iran launched missile salvos at Israelincluding strikes on Beersheba that caused casualtiesand Israel responded with airstrikes on Iranian military and nuclear sites, reportedly killing senior IRGC commanders and scientists. Trump publicly rebuked both countries-calling them out for violating the truce and even issuing a profanity-laced warning-while pressing Israel to stand down, though Israeli officials emphasized their intention to continue defensive operations. Qatar's role as a mediator was central: its emir communicated directly with Iran at Trump's request. Despite the high-profile diplomatic push and international endorsements, including from NATO and European delegations, the ceasefire remained fragile, violated almost immediately, and neither side formally confirmed its terms. The episode underscored both the U.S.'s complex balancing act between its alliance with Israel and its confrontation with Iran, and it highlighted the precarious nature of diplomatic ceasefires without enforceable mechanisms-raising concerns of a

protracted regional conflict requiring sustained international coordination.

Qatar reports no casualties from Iran's missile attack on U.S. base. Share

In response to recent U.S. airstrikes on its nuclear sites, Iran launched missiles targeting U.S. installations in Qatar and Irag, specifically aiming at the Al Udeid Air Base, which is the largest U.S. military facility in the region. Fortunately, Qatari air defenses successfully intercepted these missiles, resulting in no casualties or injuries among military personnel or civilians. The Qatari Ministry of Defence emphasized the effectiveness of its air defense systems and condemned Iran's actions as a violation of its sovereignty. In light of the escalating tensions, the Indian Embassy in Qatar issued a precautionary advisory urging Indian nationals to remain calm, adhere to local guidance, and monitor news updates. Regional reactions included strong condemnations from neighboring countries like Saudi Arabia and the UAE, highlighting a collective stance against Iranian aggression. The situation illustrates the delicate balance in Middle Eastern geopolitics, where Iran appears to demonstrate military resolve while avoiding direct confrontation with regional states. Despite the potential for escalation, the measured responses from Qatar and its allies reflect a commitment to maintaining stability and safety in the region, thereby reinforcing the importance of international dialogue and cooperation to prevent further hostilities. The incident underscores the need for vigilance among expatriates and the importance of diplomatic engagement to navigate the complexities of regional security dynamics.

India, Pakistan Extend Airspace Ban Until July 2025 Amid Tensions S SHARE

India and Pakistan have extended their mutual airspace closure until July 24, 2025, in the wake of escalating tensions following a terror attack in Pahalgam that resulted in 26 fatalities. The ban on Pakistani airlines, including military flights, initiated by India on April 30, has seen multiple extensions, reflecting the ongoing volatility in bilateral relations. India retaliated with "Operation Sindoor," targeting terror infrastructure in Pakistan, which marked a significant escalation in hostilities. This ongoing airspace situation has severely impacted Indian airlines, particularly those operating long-haul flights, leading to increased operational costs and potential losses estimated to exceed \$100 million.

As Indian carriers face extended flight times and higher fuel consumption due to rerouting, these costs may ultimately be passed on to passengers, affecting route offerings. The mutual airspace restrictions highlight the broader implications of geopolitical tensions on commercial aviation, as similar patterns are observed globally. Unless diplomatic efforts are renewed to deescalate tensions, the aviation sector, especially in India, will likely continue to face operational challenges and financial burdens stemming from these closures, reinforcing the need for constructive dialogue to restore stability in the region.

India Criticizes OIC for False Claims Influenced by Pakistan Share

India has criticized the Organisation of Islamic Cooperation (OIC) for making unwarranted and factually incorrect statements influenced by Pakistan, particularly regarding the treatment of Indian Muslims and the situation in Jammu and Kashmir. The Ministry of External Affairs (MEA) emphasized that Pakistan's attempts to politicize the OIC agenda reflect a disregard for the real threat of terrorism it harbors. India vehemently rejected Pakistan's allegations of military aggression, asserting that its Operation Sindoor was a legitimate act of self-defense against cross-border terrorism. The MEA underscores the irony of Pakistan, with its poor human rights record, lecturing others on counter-terrorism.

Bilawal Bhutto warns of war if India restricts water under IWT. SHARE

Pakistan's former foreign minister Bilawal Bhutto-Zardari warned of potential war if India denies water access under the Indus Waters Treaty (IWT), which India has suspended following a terrorist attack in Pahalgam. He emphasized that the IWT remains binding and criticized India's decision, asserting that Pakistan would pursue its share of water through its six rivers. Bilawal also highlighted the need for dialogue and cooperation against terrorism, claiming India has weaponized the issue for political gain and attempted to undermine Pakistan's standing in international financial matters. The situation underscores the fragility of Indo-Pak relations and the critical nature of resource-sharing agreements in regional stability.

Iran's missile attack in Beersheba kills four despite ceasefire claims. S SHARE

Iran's missile attack on Beersheba has resulted in four fatalities, occurring shortly after a announcement by U.S. President Donald Trump. Despite claims of a cessation of hostilities, the IDF reported multiple Iranian missile strikes post-ceasefire, signaling ongoing aggression from Tehran. The Israeli government has yet to officially confirm adherence to the ceasefire, while Iranian officials indicated they halted attacks at 4 AM local time, but not without launching barrages until the last moment. This situation underscores the volatility in the region, highlighting both Iran's persistent threat and the precarious nature of international ceasefire agreements, emphasizing Israel's need for robust defense measures.

Trump criticizes Iran and Israel following ceasefire amid conflict SHARE

The recent conflict between Iran and Israel has escalated, with US and Israeli strikes reportedly destroying significant parts of Iran's nuclear centrifuge program, according to a former UN weapons inspector. While Iran's uranium stockpile enriched to 60% remains intact, the damage inflicted by the strikes could delay Iran's ability to develop nuclear weapons by a year or two. The targeted Fordow facility, protected within a mountain, sustained critical damage, potentially crippling its operations. This situation highlights the ongoing geopolitical tensions and the importance of international oversight in nuclear matters, reinforcing the need for vigilant defense strategies in the region.

U.S. Evaluates Effects of Strikes on Iran's Nuclear Facilities Share

The U.S. recently conducted airstrikes on Iranian nuclear enrichment facilities, claiming significant damage to the targets. While President Trump and defense officials heralded the strikes as a success, experts caution that the full impact on Iran's nuclear program remains uncertain, particularly regarding underground facilities. There are concerns that Iran may have moved enriched uranium to other locations, complicating assessment efforts. Israeli officials expressed hope that the strikes would prompt Iran to negotiate a deal for denuclearization, although analysts believe rebuilding efforts could occur within a year if Iran decides to persist in its nuclear ambitions. The

situation underscores the complexities of military intervention in nuclear proliferation.

Canada and EU forge defense pact amid US tensions. Share

In a significant development, Canada and the European Union have established a pioneering security and defense partnership, marking a strategic shift for Canada as it seeks to diminish its reliance on the United States amidst President Trump's confrontational policies. This agreement, unveiled at a Brussels summit on June 23, 2025, is designed to enhance cooperation among democracies in light of global threats, including Russia's aggression and instability in the Middle East. However, the pact awaits ratification by national parliaments in ten EU member states, showcasing the complexities of international defense collaborations. This move reflects Canada's proactive approach to diversify its security alliances in an increasingly unpredictable geopolitical landscape.

Iran-Israel Conflict: Ceasefire Announced Amid Ongoing Attacks S SHARE

The recent Iran-Israel conflict saw a rapid escalation of military exchanges, starting with Iran's missile strikes on US bases in Qatar, followed by Israeli retaliatory strikes in Iran. Despite a ceasefire announcement by President Trump, hostilities continued with both sides launching attacks, illustrating deep mutual distrust. Iran's Foreign Minister expressed skepticism over the ceasefire, indicating Tehran would only halt attacks if Israel did the same. The situation remains precarious, with ongoing threats and international diplomatic efforts, including mediation offers from Russia, highlighting the complexity of the geopolitical landscape in the region.

Experts Warn Closure of Strait of Hormuz Could Disrupt Oil Supply Share

The Strait of Hormuz, crucial for global oil supply, faces potential closure by Iran, which could disrupt about 20% of the world's oil transport and spike prices to \$110-\$130 per barrel. This would significantly affect major Asian economies, including India, that depend on Gulf oil imports, leading to inflation and slowed economic growth. While Iran's parliament has suggested closure, past actions have been more symbolic, as Iran itself relies on this route for its exports. A blockade could escalate military tensions, highlighting the geopolitical

risks and economic instability that could ensue, particularly for energy-importing nations like India.

NSA Ajit Doval and Chinese FM Wang Yi Discuss India-China Relations S SHARE

National Security Advisor Ajit Doval met Chinese Foreign Minister Wang Yi in Beijing to discuss the India-China bilateral ties, emphasizing the need for counterterrorism cooperation amid recent regional tensions. Doval's remarks indirectly addressed China's relationship with Pakistan following India's military response to terrorist incidents. They also reviewed economic engagements concerning essential rare earth minerals and highlighted the importance of maintaining peace along the borders. This meeting signifies India's commitment to diplomatic dialogue and conflict resolution while seeking to normalize relations post the 2020 military standoff in Ladakh, showcasing a proactive approach to regional stability and cooperation.

India Prioritizes Nuclear Security Amid Iran-Israel Tensions Share

India's Permanent Representative to the UN, Shambhu S. Kumaran, emphasized the critical importance of securing nuclear facilities amid heightened tensions between Iran and Israel, particularly following recent US attacks on Iranian sites. He urged for utmost restraint to prevent adverse impacts on nuclear safety and called for the IAEA to monitor and report on the situation. Iran's Foreign Minister condemned the US actions, asserting Iran's right to self-defense, while the Italian and French foreign ministers expressed regret over the escalation and advocated for a return to diplomacy. India's proactive stance reinforces its commitment to nuclear security and stability in the region.

Military Operations

IAF's Operation Sindhu evacuates 594 Indians from Israel and Iran Share

24-Jun-25

Operation Sindhu, launched by India's Ministry of External Affairs on June 18 amid the escalating Israel–Iran conflict, orchestrated a large-scale evacuation of Indian citizens and select foreign nationals from the region. Employing Indian Air Force C-17 transport aircraft, the mission airlifted over 2,295 people from

Iran-including 292 evacuees from Mashhad on June 24-and more than 1,100 from Israel via transit through Jordan and Egypt. From Israel, successive flights evacuated 161 nationals from Amman and 268 from Sharm-El-Sheikh, bringing the total repatriated from Israel to 594. These evacuations followed intense hostilities—Israel's Operation Rising Lion on June 13 and Iran's subsequent retaliatory strikes-further complicated by a U.S. strike on Iranian nuclear facilities. Indian embassies in Tehran, Yerevan, Ashqabat, Amman, and Cairo coordinated land transfers and flights, while IAF C-17s remained on standby. On June 19, the first batch of 110 medical students from Urmia reached Delhi via Armenia, welcomed by External Affairs Minister Kirti Vardhan Singh. Many evacuees described harrowing experiences of midnight bombardment, sirens, missile interceptions, and limited connectivity under blackout conditions. Operation Sindhu has safely brought home some 3,170 Indian nationals, also facilitating transit for Sri Lankan and Nepalese citizens, showcasing India's rapid diplomatic coordination, humanitarian resolve, and defense readiness in protecting its diaspora during global crises. India has broadened its strategic outreach, not only engaging with Greece but also deepening ties with Cyprus, Armenia, and other nations bordering Turkey as part of a coordinated regional approach. Following Prime Minister Modi's June 16, 2025 visit to Cyprusthe first by an Indian premier in over two decades—India and Cyprus agreed to enhance defense-industry collaboration, maritime and cybersecurity cooperation, joint naval training, search-and-rescue operations, and intelligence sharing targeting terrorism, with the island's strategic position reinforcing its role in the emerging India-Middle East-Europe Corridor. Meanwhile, India and Armenia have significantly escalated military cooperation: Yerevan has acquired Indian systems including Akash surface-to-air missiles, Pinaka rocket launchers, Swathi radars, anti-tank weapons, anti-drone and ballistic missile interceptors, defense-education exchanges and the appointment of defense attaches. Armenia has become India's largest arms importer in the region, signaling a geopolitical counterbalance to the Ankara-Islamabad-Baku axis. Greece, Cyprus and Armenia have also stepped up

trilateral defense cooperation, sharing training programs, joint exercises and exploring investment in India's defence-industrial corridor in Uttar Pradesh. Together, these partnerships illustrate India's evolving defense strategy in the Eastern Mediterranean and South Caucasus, aimed at countering regional threats, improving training interoperability, and reinforcing a geopolitical network of like-minded nations neighboring Turkey.

Assam plans permanent Indian Army base in Dhubri for security. S SHARE

The Assam government, led by Chief Minister Himanta Biswa Sarma, is considering establishing a permanent Indian Army base in Dhubri district to enhance security in the wake of communal tensions, particularly incidents involving prohibited meat being thrown in Hindu temples. The Chief Minister emphasized a zero-tolerance approach to anti-social activities and highlighted the ongoing efforts to restore normalcy, including the apprehension of 150 individuals involved in unrest. Additionally, the government is taking measures to address land encroachments and promote ecological conservation in the region, illustrating a comprehensive strategy to foster peace and stability while protecting local ecosystems.

Israeli Air Force Targets Key Iranian Regime Sites in Tehran Share

The Israeli Air Force executed a significant operation against Iranian regime assets in Tehran, targeting over 50 sites associated with the Islamic Revolutionary Guard Corps (IRGC) and internal security forces. Key strikes included command centers pivotal to regime stability and repression, as well as the notorious Evin Prison. The operation, described as a preemptive measure to deter Iranian missile threats and halt nuclear ambitions, resulted in widespread disruption in Tehran, emphasizing Israel's commitment to countering both conventional and unconventional threats from Iran. This escalation highlights the ongoing geopolitical tensions in the region and the potential for internal change within Iran's leadership structure.

Pakistan Navy's Frigates Face Failures During Operation Sindoor Share

The Pakistan Navy's modernization efforts, particularly regarding its Type-054A/P (Tughril-class) and F-22P (Zulfiquar-class) frigates, have been significantly

hindered by technical failures, including defective sensors and unreliable radars. These issues were exposed during India's Operation Sindoor, revealing critical weaknesses in Pakistan's naval capabilities, which struggle to match India's advanced naval fleet. The over-reliance on Chinese defense systems, which constitute a significant portion of Pakistan's imports, has compounded these challenges, as the performance of these vessels has not met expectations. In comparison, India's defense advancements, including the upgraded BrahMos missile, provide a substantial tactical advantage in the region.

Indian Army to Add Six Pinaka Rocket Regiments by 2026 Share

The Indian Army plans to enhance its artillery capabilities by commissioning six new Pinaka rocket regiments by 2026, aimed at countering threats from China and Pakistan. This modernization involves replacing outdated Soviet systems with indigenous multi-barrel rocket launchers, under a Rs 2,580 crore contract with Indian firms. The urgency for this upgrade was underscored by the 2020 Galwan Valley clash, prompting a fast-tracked induction process. Currently, two regiments are operational, and equipment for two more is on track for delivery, reflecting India's commitment to strengthening its deterrence along volatile borders amidst ongoing military modernization by its neighbors.

Terrorism and Counterterrorism

India invests Rs 2,000 crore to boost Army's counter-terrorism capabilities. Share

The Indian Ministry of Defence has made a significant commitment to bolster the Indian Army's counterterrorism capabilities by finalizing thirteen contracts under the Emergency Procurement mechanism, amounting to approximately Rs 1,981.90 crore out of a sanctioned budget of Rs 2,000 crore. Kashmir, where recent military operations have highlighted the need for rapid capability enhancements. The expedited procurement process allows for the swift acquisition of mission-critical equipment, thereby bridging urgent capability gaps and ensuring that troops are well-equipped to tackle emerging security challenges. This strategic move reflects India's proactive stance in countering terrorism and strengthening national security through modernizing its defense infrastructure, showcasing robust commitment to indigenous manufacturing and operational excellence in high-risk environments.

India's Defence Minister Advocates Regional Cooperation Against Terrorism at SCO Meet Share

Cybersecurity and Information Warfare

Pro-Russian hackers target Dutch municipalities with DDoS attacks before NATO summit. S SHARE

Pro-Russian hackers, identifying as NoName057(16), executed coordinated DDoS attacks on various Dutch municipalities ahead of the NATO summit in The Hague, although key government services remained unaffected. The Dutch National Cybersecurity Center is investigating and has implemented "Operation Orange Shield," enhancing security protocols in response to potential threats. This incident underscores the ongoing cyber warfare tactics employed by pro-Russian groups

targeting NATO-aligned institutions, reflecting significant vulnerability cybersecurity amidst escalating geopolitical tensions. The proactive measures taken by the Dutch government and NATO demonstrate а commitment safeguarding to international cooperation and stability in the region.

India's ISRO and DRDO Develop Unhackable Quantum Network Share

India is making significant strides in developing an unhackable quantum communication network, led by ISRO and DRDO, amidst rising threats from quantum computing to traditional encryption. Palo Alto: 10% of GenAI apps deemed highrisk; India must enhance cybersecurity. S SHARE

The Palo Alto Networks report highlights that 10% of a company's GenAl applications are high-risk, with significant adoption in India, evidenced by an 890% surge in GenAl traffic in 2024. The emphasis on proactive oversight and adaptive security controls is crucial to safeguard national security and operational integrity in the face of evolving cyber threats.

Cybercriminals exploit gaming apps to rent youths' bank accounts and SIM

An investigation in Panaji has uncovered that cybercriminals are targeting youth to rent their bank accounts and SIM cards using gaming apps as bait, facilitating criminal activities. The police highlight the risks, as unwitting participants become implicated when accounts are frozen. Efforts to combat this rise in cyber fraud include the establishment of an integrated cybersecurity solution lab by the state government, with a budget of Rs 89.4 crore, aimed at enhancing detection and response to cyber threats. The initiative, led by the National Forensic Sciences University, underscores the importance of safeguarding personal information and educating youth on the dangers of cyber fraud.

Governor urges Army to mentor youth on armed forces careers S SHARE

Rahul Gandhi misses court hearing on Army insult case again. S SHARE

Miscellaneous

US House Blocks WhatsApp Amid Privacy Concerns for Meta Share

24-Jun-25

The U.S. House of Representatives has explicitly barred WhatsApp from all government-issued devices, citing serious cybersecurity and privacy concerns. A memo issued by the Office of the Chief Administrative Officer (CAO) and Office of Cybersecurity labeled WhatsApp a "high-risk" app due to its lack of transparency in handling user data, absence of encryption for stored data, and other potential vulnerabilities. Staffers have been ordered to remove the app by June 30 and switch to approved alternatives such as Microsoft Teams, Amazon's Wickr, Signal, Apple's iMessage and FaceTime. The ban reflects growing scrutiny of Meta Platforms' data practices, coming amid larger legal and political pressures, including an ongoing Federal Trade Commission monopoly case and public worries over Meta's integration of advertising into WhatsApp. Meta has strongly contested the decision, pointing out that WhatsApp offers end-to-end encryption by default and insisting it provides stronger security than many apps on the House's approved list. This move marks a significant example of how government oversight is reshaping technology use in official settings, reinforcing demands for stricter regulations while highlighting the tension between innovation, corporate practices, and national security imperatives.

Trump's actions expose Asim Munir's diplomatic misjudgment. Share

Pakistan Army Chief General Asim Munir's much-publicized White House meeting with former U.S. Donald Trump—where Trump applauded Munir's role in defusing the India-Pakistan standoff and discussed Iran-has proven diplomatically miscalculated, especially given America's recent bombing of Iranian nuclear sites. His wartime praise now appears tone-deaf after the U.S. attack, exposing the volatility of Pakistani diplomacy and the dangers of failing to anticipate domestic Meanwhile. Prime Minister consequences. Narendra Modi's decision to decline a meeting or dinner invitation from Trump-citing his schedule emphasizing direct, military-to-military resolution of the Kashmir conflict—appears prescient and cautious by comparison, reinforcing India's long-standing rejection of third-party mediation in South Asia.
